## What is it?

The Individual Development Account (IDA) is a matched savings program that can help you:

- \* Buy a home
- \* Repair a home
- \* Purchase a car
- \* Grow your business
- \* Go to college

## How does it work?

Participants in the program make monthly deposits of \$25 to \$100 into an IDA savings account - up to a maximum total savings of \$2,000. Your deposits are then matched with **three** times your deposited amount. If you save the maximum, you will end up with \$6,000 of match money to invest in your home, business, car or college fund - totaling \$8,000! Each year you are enrolled in the program you will be required to complete a financial education course as well as an asset specific education course such as home-buyer education or home maintenance workshops.

## Who can participate?

To qualify, the household income must be under the stated income guidelines below **OR** eligible for EITC **OR** eligible for TANF benefits. There must be **earned income** in the household and the household must also have assets that total less than \$10,000.
